## TOUR TERMS & CONDITIONS

### 1. PART 1 – GENERAL TERMS THAT APPLY TO ALL ADAM MONK PHOTO TOURS

**1.1 How to book a tour:** Please email your completed and signed Booking form AND Acceptance of Risk form to [tours@adammonk.com](mailto:tours@adammonk.com) and pay the tour deposit via EFT to the bank details specified on the previous page.

The number of participants on a tour is limited and places will be assigned on a first come, first served basis. Once we have received and confirmed your Booking and Acceptance of Risk forms, and your tour booking deposit, we will send you an invoice/receipt for the tour cost. Until the tour Deposit has been paid in full and confirmed by us, your place on the tour is not guaranteed.

**1.2 How to pay for a tour:** Payments must be made by electronic funds transfer to Adam Monk Photo Tours. Full details of how to pay for a tour AND the date by which payment is required by are set out in Part 3.

**1.3 Changes to the Itinerary:** The itinerary for tours is flexible and expressly subject to changes without notice as seen fit by Adam Monk Photo Tours to adapt to changing conditions. The aim of the tour is to provide all participants with the best photo opportunities possible under the prevailing circumstances.

**1.4 Health Concerns:** If you have any medical or health concerns please contact us to discuss this prior to sending in your Booking form. It is a mandatory requirement that you disclose in writing to us all health issues and any physical conditions that could potentially pose a risk to yourself or others on the tour. We cannot accept the responsibility of medical care for any participant and reserve the right to cancel your participation in this tour on that basis. In the event this occurs you will be refunded as per our refund policy set out in this form.

Our tours are designed for adults in reasonable health and of moderate fitness. The tour may involve walking and hiking on trails, uneven surfaces and up and down inclines. You will be required to carry your own equipment and water.

You may also need to obtain medical vaccinations, depending on the tour location and should seek medical advice to determine if this is needed for you.



**1.5 Diet:** If you have special dietary needs or food allergies you must disclose these to us prior to booking. We will endeavour to cater for special dietary requests, but this is your responsibility and we cannot be held liable for these requests not being met.

**1.6 Travel Insurance:** It is your responsibility to provide for your own travel insurance for the duration of the tour. It is a mandatory condition of tour participation that you have full insurance cover and we require confirmation of this prior to the commencement of the tour. You must provide us with full details of your insurance cover, including provider name, policy number & 24 hour emergency phone number; either by email or post.

We recommend you take out insurance immediately at the time you book and pay the deposit for this tour.

### 1.6.1 Your Travel insurance must include cover for:

1. The full and correct dates of travel, including transit days.
2. Full tour costs if **you** are forced to cancel just before departure.
3. All your airfares and extras if **we** are forced to cancel the tour.
4. Full emergency evacuation and repatriation expenses.
5. Lost luggage, flights and full cancellation fees.

### 1.6.2 Credit Card Insurance cover.

Many credit card companies offer travel insurance as a part of their card package. They usually provide very little information about the details of this insurance. It is your responsibility to ensure you meet the requirements of your credit card company insurance to be effectively covered, and that this insurance cover meets the standard as laid out above.

**1.7 Camera and other Insurance:** We recommend that you also take out insurance to cover your Camera and other possessions whilst on the tour.

**1.8 Tour Price and Accommodation:** The Tour price is based upon double/twin share accommodation. If you wish to share accommodation you must nominate another participant (partner or friend) to share with. We will not pair you with another participant who is unknown to you, unless specified otherwise in Part 3 of these Terms & Conditions: *Tour Specific Terms*.

**1.9 Single Supplement Option:** The Single Supplement option entitles you to private hotel rooms for the tour and usually a private bathroom unless specified otherwise in Part 3 of these terms and conditions. If you are travelling alone, and you are unable to, or do not wish to nominate another participant to share hotel rooms with, then the Single Supplement component becomes automatically payable, and will be added to your total cost for the tour. In this case, **Twin Share price + Single Supplement = Total Tour Cost**. Unless otherwise specified in *Part 3 Tour Specific Terms* of These Terms & Conditions.

**1.10 Bookings and Payments Waiting List:** Should your Booking form be received after the tour has become fully booked, we will contact you and place you on the waiting list. Places on the tour will be booked, and the waiting list maintained in the order booking forms are received. We will keep you up to date if any places becoming available.



**1.11 General Cancellation & Refund Policy:** We have tried to make our Cancellation & Refund policy as fair and equitable as possible. Circumstances change and unexpected things happen, so the best thing to do is contact us and we will do our utmost to help out.

Our General cancellation and refund policy is set out below. Please note that there may be specific cancellation and refund policies for your specific tour. Those tour specific cancellation and refund policies are set out in Part 3 with the specific tour information and are in addition to this General cancellation and refund policy.

If there is any conflict between this clause and the specific tour provisions, the specific tour provisions take precedence.

### 1.12 Cancellation and Refund Policy detail.

1. A tour may be cancelled if there are an insufficient number of participants or if it is deemed inadvisable to run the tour. A decision to cancel a tour for insufficient numbers or any other reason is in the sole discretion of Adam Monk Photo Tours.
2. In the event Adam Monk Photo Tours cancels the tour you will be refunded all monies paid to us subject to the conditions of clause 1.13 - 1.15 below.
3. Your participation on the tour may be cancelled if we do not receive full payment by the date specified in Part 3.
4. Your participation on the tour may be cancelled if, in Adam Monk Photo Tours discretion, your behaviour adversely impacts, or is likely to adversely impact, any person involved on the tour (including Guides, interpreters or other service providers). Adverse impact includes endangering the health and safety of any person, causing personal injury or loss of or damage to property of any person involved on the tour.
5. All cancellations requested by you must be made by email to [tours@adammonk.com](mailto:tours@adammonk.com). Calculation of dates will be based on the date we receive your email.
6. If you cancel your place at any time but we manage to sell your spot again and the tour is otherwise filled, we will refund you the full tour cost you have paid to us less (a) the amount of US\$250 service charge and (b) any reasonable costs incurred in re-advertising and promoting your place.
7. If you cancel your place and the tour does not fill, then you will be refunded according to the following schedule, based on money actually paid to us towards the full cost of the tour:
  - a) Greater than 90 days from the start date of the Tour: Full refund less US\$250 service charge.
  - b) Up to 75 days prior to tour commencement: 75% refund
  - c) Up to 60 days prior to tour commencement: 50% refund
  - d) Up to 45 days prior to tour commencement: 25% refund
  - e) Less than 45 days to tour commencement: no refund will be made.

**1.13 Refund Method:** Refunds will be made by the same method as the original payment and in the same currency. Refunds will be initiated within 14 working days from the time the refund request is approved by us. All refunds are limited to the Tour cost or paid portion thereof as outlined in these Terms and Conditions and actually paid to us in the currency paid to us. No refund of Bank fees, currency value fluctuation differentials, transfer charges, airfares, insurance or other incidental costs will be made.

**1.14 Part Refunds:** No part refunds will be made for unused portions or services of the tour.

**1.15 Refunds and responsibility:** Adam Monk Photo Tours are not responsible for, and will not provide, any refund for portions of the tour itinerary or services missed due to delayed or cancelled air services, third party travel arrangements or any other circumstances beyond our control. This includes but is not limited to cancellations or delays due to weather, road conditions, mechanical breakdowns, war, political instability and “acts of God”.

**1.16 Privacy:** Adam Monk Photo Tours will not share your personal information with any third party other than to the extent necessary for the operation of the Tour.

**1.17 Image Release:** During the tour, Adam Monk Photo Tours may take photographs of you and other participants of the tour for publicity purposes. You agree to the taking and publication of photographs of you by Adam Monk Photo Tours solely for publicity purposes.



### **2 PART 2 – RESPONSIBILITY AND LIABILITY**

**2.1** The liability of Adam Monk Photo Tours is strictly limited.

**2.2** Adam Monk Photo Tours organises, operates, promotes and sells photography tours and workshops that consist of goods and services purchased from various other suppliers. Adam Monk Photo Tours does not own, operate or have a financial interest in any of these suppliers and as such is not responsible for any negligent act, failure or omission of said suppliers. By signing up and agreeing to take part in this tour you agree to indemnify Adam Monk Photo Tours, its directors, its agents, partners, employees or associates from any failings of such suppliers.

**2.3** Adam Monk Photo Tours, its directors, agents, partners, employees or associates cannot be held responsible for losses or extra expenses caused by but not limited to, weather conditions, change in travel schedules, transportation services, illness or injury or other factors that may affect participants travel plans or arrangements, or loss or damage to personal items including but not limited to camera and computer equipment. All such losses are the sole responsibility of the participant.

**2.4** Adam Monk Photo Tours reserves the right to cancel any tour, or your place on any tour or prior to commencement.

**2.5** In the event we cancel the tour or your place on the tour, you will be refunded according to the General Cancellation and refund policy and any specific cancellation policies for your Tour (found in Part 3 of this document). All refunds are limited to the Tour cost or portion of tour cost actually paid, and will be refunded in the original manner and currency paid to us. We are not liable for bank fees, currency value fluctuation differentials, transfer charges or other incidental costs or extra travel arrangements such as but not limited to flights, insurance and additional accommodation arrangements.

**2.6** Adam Monk Photo Tours reserves the right to substitute accommodation of a similar kind for those indicated in any issued itinerary and to alter said itinerary or transport arrangement where it deems necessary.

**2.12** These Terms & Conditions and Booking and Acceptance of Risk forms are governed by the laws of Western Australia and in all cases will be interpreted in accordance with those laws and any dispute is subject to the non-exclusive jurisdiction of the Courts of Western Australia.

3.1 Your tour is the Autumn Colours of Japan, November 2020.

3.2 **Tour Start date & location:** 13th November 2020 in Tokyo, Japan.

3.3 **Tour End date & location:** 23rd November 2020 in Kyoto Japan.

3.4 **Tour leaders:** Adam Monk and Robert van Koesveld

3.5 **Number of Tour Participants:** This tour will have a maximum number of ten (10) participants. In addition to the ten (10) participants there will be the Tour leaders and Japanese guides. A minimum number of six (6) participants is required for the tour to run, Adam Monk Photo Tours may, at its discretion, run the tour with less than six (6) participants. Adam Monk Photo Tours may, at its discretion, run the tour with eleven (11) participants in the event there is just one (1) place remaining and a couple wishes to book.

#### 3.6 Tour details Pricing & Inclusions

- Deposit to confirm your place: **JPY160,000 (Approx US\$1,500) Per Person (this deposit forms part of the total tour cost).**
- All funds for tour price, deposit and single supp must be paid in Japanese Yen. See section 3 below for details.

### *b) The Above Tour Price Does Not Include*

- Flights to Japan from your home port and return.
- Japan Visa (if you require one, please check with your travel agent).
- Initial transfer from the airport to the hotel in Tokyo.
- Transfer to Osaka airport at the conclusion in Kyoto.
- lunches on tour in Japan.
- Travel insurance (required as a condition of booking).
- Camera Insurance.
- Alcohol and extra beverages.
- Any extras you may wish to buy along the way.
- Tips for local guides (optional).
- Adobe Lightroom software subscription fees.

### **3.7 Payment for the Tour**

1. The final balance of Tour price must be paid by 5pm (AEST) on **13th August 2020** (90 days prior to the tour commencing.) This payment date will be specified in the invoice/receipt we will email you upon receipt of your deposit. In the event you book this tour after the above due date the full tour price becomes immediately payable.
2. *Payment Options.*
  - a) You must pay all monies by electronic funds transfer in **Japanese Yen** to our **JPY Bank account** (See page 1 of these T&Cs for account details).
  - b) We do not accept payments in any other currency or any other method. The **JPY** amount of funds that land in our account must match the amount due exactly. We are not responsible for any fees that may be incurred with Electronic Funds transfer from your Bank or any intermediary Bank to our bank account. Please ensure that all Bank and transfer fees are paid at your end of the transaction and are not deducted from the total figure transferred. This is a common mistake and results in incomplete payment. Payment shortfall arriving in our bank will be reflected in the invoice for final balance of payments.

### *Why do we only accept EFT and not Credit Cards?*

Our aim is deliver the best value tour or workshop possible, that means cutting out unnecessary costs.

Electronic Funds Transfer is the most cost efficient method to transfer money nationally and internationally. Credit Card companies charge substantial hidden fees. You won't see the fee when you pay, the fee is deducted at our end as a percentage. As these tours and workshops involve substantial payments, the credit card fees are substantial too. We then need to add that fee back to the cost of the tour, and the tour price goes up accordingly. Not the outcome we are after.

### *Why is this tour charged in JPY?*

Our Japanese suppliers charge us in **JPY** so we have two options.

1. Charge you in **JPY** so the price remains stable and you know exactly what the cost is.
2. or Charge you in **AU\$** then build into the Terms & Conditions a clause where we charge you more if the exchange rate varies, which it almost certainly will.

We think the first option is more fair and transparent, so we charge this tour in **JPY** only.



### *A Suggestion on International Transfers & Exchange Rates.*

Because this invoice is to be paid in JPY it may be considered an international transfer by your Bank (depending on the currency you are transferring from). Your Bank may charge you a transfer fee and an international exchange fee plus they will give you a very poor exchange rate.

The most fee economical way to do an international transfer is to open a Forex (foreign Exchange) account with a company such as World First (*worldfirst.com*), which usually takes about 15 minutes. The exchange rate will be considerably better, and their fees are significantly less. On a substantial transfer this will save you quite some money.

### **3.8 Booking Your Travel Arrangements to Japan**

The tour begins in **Tokyo** and ends in **Kyoto**, Japan. You will need to arrange your own flights to and from Japan plus any additional nights of accommodation and meals not specifically listed as included in the tour price. It is your responsibility to ensure you arrive at the hotel in **Tokyo** in a timely manner prior to the commencement of the tour. Adam & Robert are happy to discuss this with you to offer suggestions and advice at the time of booking.

We recommend that you do not book any flights or other travel arrangements until we confirm to you in writing that the tour has sufficient numbers and is going ahead as planned. Please note that we will not be responsible for any costs incurred by you for any travel arrangements.

### **3.9 Hotel List**

So you can book any extra nights before or after the tour, we will supply you with a hotel list approximately three (3) months prior to departure when all accommodation is finalised and confirmed. Due to the nature of Hotel bookings in Japan we are unable to supply this list earlier.

### **3.10 Extra nights accommodation at the start or finish of the tour.**

We cannot book extra nights accommodation for guests at either the start or the finish of a Tour.

Past experience has shown us that we are simply not equipped to handle this as we are not travel agents. Japan can be especially difficult as hotel prices and availability fluctuate wildly in just a few days, so it's impossible to reliably quote prices.

### **3.11 Tour Specific Cancellation and Refund policy**

This 2020 Autumn Colours of Japan Photo Tour contains several train journeys of a nonrefundable nature, according to the third party supplier. Should you cancel your place on this tour after these bookings have been made and deposits paid, we will attempt to promote and sell your place on the tour...

1. If we are successful and the third party suppliers allow, we will transfer those bookings into the name of the new participant. In this situation you will be refunded according to the *"1.11 General Cancellation and refund Policy"* specified earlier in this document, minus whatever re-booking fees are charged for the transfers.
2. If we are not successful in selling your place those nonrefundable components will be deducted from the total refund to be paid to you according to *"1.11 General Cancellation and refund Policy"* specified earlier in this document.
